## FIRE DEPARTMENT MONTHLY REPORT

## September 2021

This month's activities resulted in Station 36 responding to **113** calls for service; **80** incidents were for Emergency Medical Services and **33** incidents were fire suppression related. BLS care was rendered on **17** incidents while ALS care was rendered on **48** calls. The remaining EMS calls did not require medical care. Station 36 responded to **47** calls within our section of the Village of Inverness and **1** call in Barrington-Countryside's portion of the Village.

#### Calls of Interest

Sept 4 <sup>th</sup>	Ambulance 36 responded to a vehicle accident with entrapment in
	Barrington-Countryside District 37. A36 transported a Level-1
	trauma patient to Lutheran General Hospital.

Sept 5<sup>th</sup> Engine 36 and Ambulance 36 responded to a cardiac arrest. With the assistance of E23, the patient was successfully resuscitated and transported to SAMC.

Sept 16<sup>th</sup> Engine & Ambulance 36, along with Battalion 8 responded to a car vs tree accident. Crews found a pickup truck into a tree that had significant damage and a critically injured patient trapped in the vehicle. E36 called for additional resources and began extrication while A36 initiated patient care. TWR 85 and E23 assisted with the extrication and the patient was transported to LGH.

Sept 16<sup>th</sup> Engine 36, Ambulance 36 and 701 responded to a rollover accident on Bradwell Road. One vehicle was on its roof and another had significant damage, but all patients had self-extricated. One patient was transported to NWCH and vehicle hazards were mitigated.

Sept 18 <sup>th</sup>	Tender 36 responded to a Box Alarm fire in Mundelein (Countryside FPD).
Sept 18 <sup>th</sup>	Ambulance 36 & Engine 36 responded for a fall victim with a head injury. Patient was transported to Lutheran General Hospital.
Sept 30 <sup>th</sup>	Ambulance 36 responded to a cardiac arrest in Palatine District 81.  Crew worked with Engine 81 and Engine 84 crews to successfully resuscitate the patient who was then transported to NWCH.


