FIRE DEPARTMENT MONTHLY REPORT

November 2016

This month's activities resulted in Station 36 responding to **90** calls for service; **60** incidents were for emergency medical and **30** incidents were suppression-related. Station 36 responded to **35** calls within our section of the Village of Inverness and **5** calls in the other side of Inverness. The District logged **9** calls within the Southeast Area and **19** incidents in all other contract areas for an overall total of **118** calls.
