FIRE DEPARTMENT MONTHLY REPORT

May 2020

This month's activities resulted in Station 36 responding to **48** calls for service; **24** incidents were for emergency medical and **24** incidents were suppression-related. BLS care was rendered on **6** incidents while ALS care was rendered on **13** calls. The remaining medical did not require medical care. Station 36 responded to **24** calls within our section of the Village of Inverness and **1** call in the other side of Inverness. The District logged **8** calls within the Southeast Area and **12** incidents in all other contract areas for an overall total of **68** calls.

Calls of Interest

May 5th: Engine 36 responded into Barrington for a structure fire. E36 manned an attack line and performed debris overhaul prior to being released.

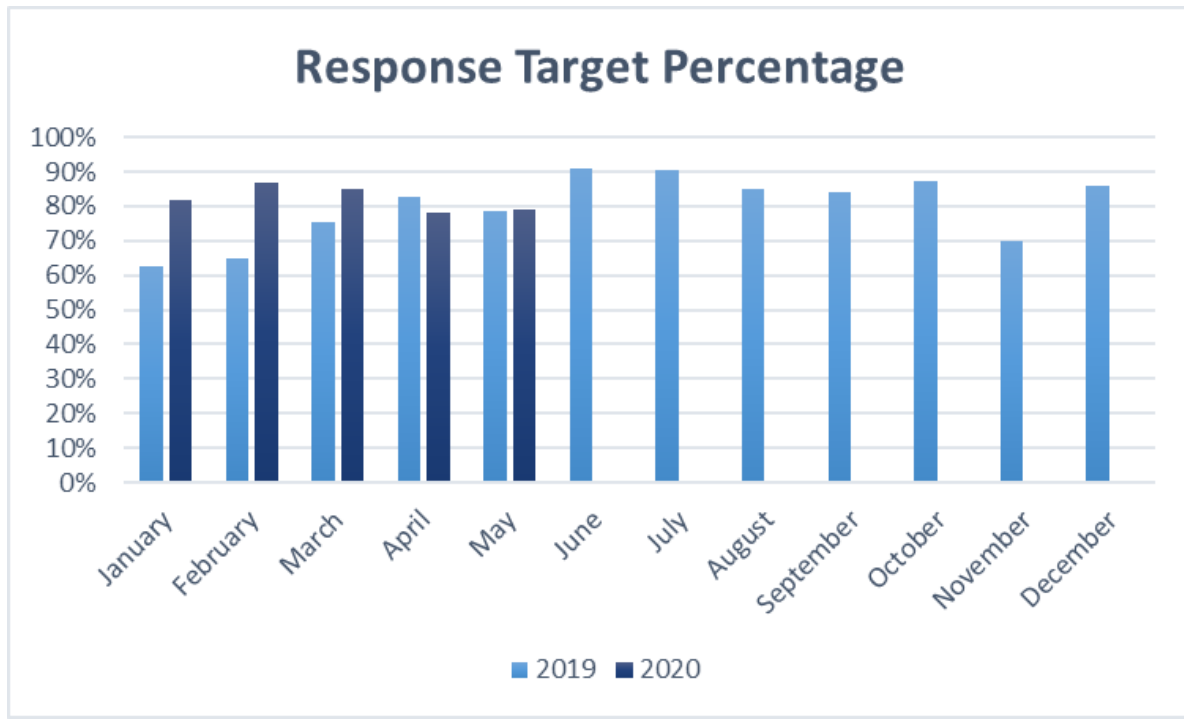
May 15th: District 36 responded to a lightning strike on Tweed Rd. Inverness. Upon arrival damage was found to an interior wall with no visible fire. Ventilation and overhaul of the area was performed in that area to ensure there was no fire extension.
