December 31, 2023, the ending market value is \$120,680. Mr. Sawyer reviewed the Market Commentary, Credit Rating Report and Transaction Ledger Report with the Board.

Firefighters' Pension Investment Fund – Marquette Associates: The Board reviewed the Firefighters' Pension Investment Fund Monthly Summary prepared by Marquette Associates for the period ending December 31, 2023. As of December 31, 2023, the one-month total net return is 4.8% and the year-to-date total net return is 15.5% for an ending market value of \$8,410,260,043. The current asset allocation is as follows: Total Equity at 66.7%, Fixed Income at 27.8%, Real Estate at 4.7% and Cash at 0.8%.

Firefighters' Pension Investment Fund – Statement of Results: The Board reviewed the Firefighters' Pension Investment Fund Statement of Results for the period ending December 31, 2023. The beginning value was \$18,823,699.26 and the ending value was \$19,961,369.18. The net return was 4.79%. A motion was made by Trustee Maxwell and seconded by Trustee McGarry to accept the Sawyer Falduto Asset Management Investment Performance Review as presented. Motion carried by roll call vote.
