## FIRE DEPARTMENT MONTHLY REPORT

#### August 2020

This month's activities resulted in Station 36 responding to **57** calls for service; **39** incidents were for emergency medical and **18** incidents were suppression-related. BLS care was rendered on **8** incidents while ALS care was rendered on **29** calls. The remaining medical did not require medical care. Station 36 responded to **38** calls within our section of the Village of Inverness and **0** calls in the other side of Inverness. The District logged **8** calls within the Southeast Area and **15** incidents in all other contract areas for an overall total of **80** calls.

### **Calls of Interest**


- August 10<sup>th</sup> A significant weather event passed through the area around 3:30 in the afternoon which resulted in several calls for service. These calls for service were due to power outages and reported power lines down. No significant damage was noted within the District. Station 36 was on generator power for several hours.
- August 22<sup>nd</sup> Ambulance 36 responded into Wheeling on a Box Alarm. While on that assignment the ambulance transported 1 patient.
- August 25<sup>th</sup> District 36 was dispatched to an outside fire with the residence as a possible exposure. Upon arrival a pool heater was found to be involved. The fire was quickly extinguished after the gas supply was turned off.
